**RESOLUTION NO. 2019-02**

**LAUDERDALE LAKES LAKE MANAGEMENT DISTRICT  
WALWORTH COUNTY, WISCONSIN**

THE COMMISSIONERS FOR THE LAUDERDALE LAKES LAKE MANAGEMENT DISTRICT DO HEREBY RESOLVE  
AS FOLLOWS:

WHEREAS, the Lauderdale Lakes Lake Management District collects yearly special assessments for septic pumping to protect the Lakes through a septic pumping program; and

WHEREAS, the yearly special assessments are collected from those Lake District properties that have septic tanks; and

WHEREAS, the yearly assessments are utilized to finance the septic pumping for those Lake District properties with septic tanks once every three years; and

WHEREAS, due to an error, the 2018 Town of Sugar Creek tax bills did not include the special assessment for septic pumping for Lake District properties; and

WHEREAS, the funds due to be collected from the Town of Sugar Creek for septic pumping are necessary for the continuation of the program and protection of the Lakes;

NOW, THEREFORE, BE IT RESOLVED THAT the Lauderdale Lakes Lake Management District will collect the 2018 special assessments for septic pumping for the Town of Sugar Creek properties not collected on the 2018 tax bills, along with the 2019 special assessments for septic pumping on 2019 property tax bills, resulting in the owners of those properties paying two special assessments for septic pumping for that one year.

BE IT FURTHER RESOLVED that property owners in the Town of Sugar Creek shall be notified of these special assessments at the Lauderdale Lakes Lake Management District's Annual Meeting and Budget Hearing and by a copy of this resolution being sent to the permanent mailing address for such properties on file at the Walworth County Treasurer's office utilized for the mailing of property tax bills.
